1. Due notice has been given to the required parties.
2.  The minor(s) do not have parent(s) ready, willing, and able to carry out day to day decisions.
  - The minor(s) parent(s) has/have consented to the appointment of the proposed guardian as guardian of the minor(s).
  - After diligent search, the parent(s) are unknown or unable to be found.
  - The parental rights of the mother and father have been terminated by court order.
3. It is in the best interest of the minor(s) that \_\_\_\_\_ be appointed (co-) guardian(s) of the  person  estate  person and estate.

THE COURT HEREBY ORDERS that:

1. \_\_\_\_\_ is appointed plenary (co-) guardian(s) of the  person  estate  person and estate, of the minor(s). Guardianship shall continue until the minor(s) attain eighteen years of age or further order of court.

2. Letters of Office shall issue upon the filing of an Oath of Office and Bond.
3.  The Guardian(s) of the Estate shall file an Inventory within 60 days.
4.  The filing of an Inventory is waived, as the Minor has nominal assets.
5.  The Guardian ad Litem is awarded a fee in the amount of \$\_\_\_\_\_.
6.  The Guardian(s) of the Person is ordered to file an Annual Report on Minor, on the anniversary of the date the guardianship was established. The form may be downloaded from the McLean County Circuit Court website:
