• MCHD is monitoring cases of COVID-19 on populations by gender and race/ethnicity.

o Gender: Female – 60% (82); Male – 39% (54)

o Race: White – 58.8% (80); Black – 31.6% (43); Other – 4.4% (6)

Ethnicity: Non-Hispanic – 91.9% (125); Hispanic – 6.6% (9)

• 74% (101) of the confirmed cases have recovered.

Confirmed Cases – 136 (as of 5/14/2020)

Deaths – 4 (as of 5/14/2020)

McLean County Health Department (MCHD) Activities

- MCHD is working with community partners (hospitals, higher education, FQHC) to plan for community-based testing efforts.
- MCHD is educating McLean County residents through social media and the MCHD website regarding preparations for maintaining social distance and non-pharmaceutical interventions while the state prepares to re-open through the phase approach outlined in 'Restore Illinois'.
- MCHD is communicating with local elected officials, community leaders, and regional Health Department Administrators to evaluate the county's potential participation in 'Heart of IL' plan to reopen through a phase approach in a sub-region of the 'Restore Illinois' plan.
- MCHD has been conducting activities to ensure that public messaging is appropriate for all McLean County populations, including:
 - o Providing a digital communication package to community leaders
 - Conducting surveys through community leaders
 - Conducting a focus group to assess public messages
- MCHD Environmental Health has been addressing complaints regarding violation of the governor's executive orders.
- MCHD is providing personal protective equipment (masks; gloves; gowns; face shields) and hand sanitizer to identified community partners.

McLean County Health Department COVID-19 Update

- MCHD is still open with some service modifications. Clients are asked to reschedule appointments for services if sick.
 - All clients are asked to wear a face covering while seeking services.
- Communicable Disease staff are tracking positive COVID-19 cases and investigating close contacts to determine need for isolation (COVID-19 positive) or quarantine (suspected to have been exposed to someone who is COVID-19 positive).
- Communicable Disease staff are taking steps to increase contact tracing capabilities in preparation for increased cases during 'Restore Illinois'.
- MCHD is planning for the use of alternate housing and alternate care facilities.
- MCHD is coordinating response activities through the McLean County Emergency Operations Center.
- MCHD is seeking volunteers for the MCHD Medical Reserve Corps. https://health.mcleancountyil.gov/273/Medical-Reserve-Corps
- MCHD is promoting key messages to the public to practice non-pharmaceutical interventions, to only access medical services if experiencing medical emergencies and to follow current Executive Orders.

Expectations for the Community

- All residents who fit testing criteria should seek testing at the Community-Based Testing Site located at the Interstate Center (1106 Interstate Drive, Bloomington).
 - Testing Criteria has changed to include the following
 - Symptomatic Have COVID-19 symptoms (cough, shortness of breath, fever, chills, repeated shaking with chills, muscle pain)
 - Have a risk factor, such as contact with someone confirmed to have COVID-19 or a compromised immune system or a serious chronic medical condition
 - Essential Personnel (with or without symptoms)
 - Medical Personnel
 - Work in correctional facilities, such as jails or prisons



McLean County Health Department COVID-19 Update

- First Responders
- Support critical infrastructure, such as workers in grocery stores, pharmacies, restaurants, gas stations, public utilities, factories, childcare and sanitation
- Any resident with symptoms
 - Must be able to follow directions and to complete the self-swab on their
 - Minors must be accompanied by an adult.
- The testing site is open 7 days per week from 9:00 am to 5:00 pm. (subject to change)
- Report violations of the governor's executive orders to McLean County law enforcement and the McLean County Health Department environmental health program.
- Assume COVID-19 is in all communities and take the necessary precautions to protect yourself.
- Observe the governor's executive orders and only leave your home if necessary.
- Older people and people with severe chronic conditions should take special precautions because they are at higher risk of developing serious COVID-19 illness.
- Practice non-pharmaceutical interventions recommended by the CDC, including:
 - o Practice social distancing. Maintain at least 6 feet from others at all times.
 - Avoid sick people. Stay home when you are sick.
 - Wash hands (soap and water or use hand sanitizer that is at least 60% alcohol)
 - Cover cough and sneezes
 - Disinfect surfaces regularly
 - Wear face covering in public when social distancing (at least 6 feet from other people) cannot be maintained.
