**APPLICATION FOR McLEAN COUNTY CLASS G  
OUTDOOR GARDEN LIQUOR LICENSE**

**I understand that Class G licenses may only be issued to Class A or B license holders.**

**At this time, I am also applying for a Class A or Class B license (circle one).**

I understand that an Outdoor Garden is defined as an approved and licensed outdoor area immediately adjacent to the premises where alcoholic beverages are sold and consumed, and where such premises holds a current and valid Class A or B liquor license.

I understand that a Class G License authorizes the retail sale of alcoholic beverages in outdoor gardens for consumption in the outdoor gardens.

I understand that an outdoor garden's hours shall be the same as the hours for a Class A or B liquor license.

I understand that it is unlawful for any person to carry any alcoholic beverages in any unsealed or opened container from the licensed premises and/or the outdoor garden where alcoholic beverages are sold and consumed.

I understand and agree that the holder of a Class G license shall be the same person or entity that is the holder of a Class A or B license for premises immediately adjacent to the outdoor garden.

I understand and agree that before a Class G license may be issued, I must obtain and attach a Special Use Permit from the McLean County Board after hearings are conducted by the McLean County Zoning Board of Appeals, and a Building Permit from the Building and Zoning Department in accordance with the requirements of Chapter 40 of the McLean County Revised Code entitled "Zoning Ordinance," as amended.

I understand and agree that before a Class G license may be issued, site plans, construction or remodeling plans, operational plans and/or other information and documentation may be requested for review and approval by the McLean County Health Department and McLean County Building and Zoning Department.

I understand and agree that the McLean County Liquor Control Commission may require the erection of fences, walls or similar barricades; restrict or prohibit the use of sound amplifying devices; and create conditions to minimize the impact on parking, vehicular traffic and pedestrian traffic prior to issuance of a Class G license.

I am completely familiar with the terms and provisions of Chapter 26 of the McLean County Revised Code entitled "Food Service," as amended, and Chapter 40 of the McLean County Revised Code entitled "Zoning Ordinance," as amended.
